YOUR CAR and CLASS:

Select one of four competitive TSD Rally Classes based on your car's model year and rally equipment, or the non-competitive Challenge/Tour Class. Rally cars may be sports cars, sports sedans, GTs, or other interesting cars. Vintage rally cars are those of model year 1989 and older; Modern Classic rally cars are those of model year 1990 through 2024. Cars of any type and model year are welcome on the Tour.

TSD Rally teams using any calculating device or rally tables must select the "CALC" class for the age of their car; those rally teams not using calculating devices or rally tables are in the "SOP" ("Seat of Pants") class for the age of their car. All rally cars are limited to using original equipment speedometers and odometers. Please refer to the General Instructions posted on www.northwestclassicrally.org for complete class definitions.

YOUR LODGING:

You will make your lodging reservation directly with *The Inn at Cross Keys Station* in Madras, Oregon, at 541-475-5800. Single King rooms are \$166 or Double Queen rooms are \$176 per night (plus taxes) with a two-night minimum. Breakfast is included for Saturday. Your reservation is for June 28-29, 2024 (Friday & Saturday nights, checkout Sunday). The Group Rate is **NW CLASSIC CAR**; block is active through May 31, 2024. A valid credit card is required for first night as advance deposit; cancellation must be received before 2 PM 24 hours prior to arrival, or one-night room charge and tax will be assessed. No pets are allowed; service animals are permitted with advance notice to staff.

OUR FINE PRINT:

- **Registration Limit:** This event is limited to 62 registrations, and we expect it to fill quickly. Please register early to avoid disappointment.
- **Hotel Lodging Limit:** The Inn at Cross Keys Station NWC room block will be released after May 31, 2024. Reservations requested after May 31, 2024 may still be available at the NWC rate but are not guaranteed and will be on a space available only basis.
- **Rally Cancellations and Refunds:** We will make every effort to accommodate cancellations and refund requests. However, we must sign contracts, place orders and otherwise commit funds well in advance. Full refund for withdrawal prior to March 16 less \$25 fee.
